

## Mail Order or Internet Sales of Non-prohibited Firearms, Airguns, Non-prohibited Magazines, Non-prohibited Parts, Ammunition and/or Pistol Carbine Conversion Kits

### NZ Police Mail Order & Internet Sales – Section 43A (1)&(2); Arms Act, 1983

New firearms laws relating to Mail order or Internet sales of arms items or ammunition, have amended the Arms Act.

#### Notes for applicants

- This form is used to apply for approval of the sale and purchase of non prohibited arms items and ammunition by mail order or on the Internet.
- You may not take possession of any non-prohibited firearm, airgun, non-prohibited magazine, non-prohibited part, ammunition and/or pistol carbine conversion kit unless you have a current firearms or dealer licence.
- If you are purchasing an airgun, you need to be 18 years of age or older if you do not have a firearms licence.
- If you are purchasing a pistol carbine conversion kit, you need to also have:
  - an endorsement to possess a pistol; and
  - a pistol that you have recorded against your endorsement through a permit to possess or import; and
  - a permit to possess the pistol carbine conversion kit.
