

MINOX Lifetime Total Coverage Warranty

Terms and Conditions

This warranty covers the following product lines only:

ZP, ZE, ZA-HD, ZA, ZV Riflescope Lines APO HG, HG, BL, BD, BV, BF, BN Binoculars MD Spotting Scopes

All other MINOX products not included in the above list are exempt from the MINOX Lifetime Total Coverage Warranty.

IMPORTANT: Your MINOX product must be registered within 30 days from the date of purchase to obtain the exclusive MINOX Lifetime Total Coverage Warranty. Be sure to register your product online at www.minox.com/usa/warranty.

- 1) Congratulations on the purchase of your MINOX product. By registering your purchase, you will gain the full benefits of our MINOX Lifetime Total Coverage Warranty. This extraordinary plan provides protection against manufacturing defects, functional failures, or any accidental damages to the covered product, such as breakage, water damage, or accident. Specifically excluded are occurrences of loss, theft, fire, and deliberate damage.
- 2) The MINOX Lifetime Total Coverage Warranty provides for repair or replacement for any problem that prevents the proper optical or mechanical function of the covered product. Cosmetic or other signs of normal wear and tear on external surfaces including lenses, are not considered as affecting optical or mechanical function of the product.
- 3) Specifically excluded from the MINOX Lifetime Total Coverage Warranty are detachable oculars and all accessories such as cases or covers, rain guards, lens caps, etc. which might be included within the scope of delivery, as well as all analog or electronic devices integrated into the product such as a digital or analog compass or illuminated reticle.
- 4) Following registration of your purchase, MINOX USA, Inc. will repair or replace the registered product at no charge during the lifetime of the original purchaser. The MINOX Lifetime Total Coverage Warranty is not transferable. To gain required service, the covered product should be forwarded to MNOX USA, Inc. directly in person or by prepaid and traceable postal or other public carrier.
- 5) Product replacement, if required, will be with a functionally identical or like-featured product that may be either new or refurbished as determined by MINOX USA, Inc.
- 6) In the event that any devices or accessories other than those distributed or officially recommended by MINOX are attached or connected to the product, in such a manner that the original factory construction is altered, any damage resulting to the product will not be covered by the MINOX Lifetime Total Coverage Warranty.
- 7) In the event any individual, firm, shop, etc. other than those specifically authorized by MINOX USA, Inc. or its authorized agents tampers with the product in a manner other than required by MINOX USA, Inc. for normal operation of the product, any damages occurring will not be covered by the MINOX Lifetime Total Coverage Warranty.

- 8) Recovery under any implied warranty of the merchantability and/or fitness that you may have hereunder is limited to repair or replacement of the product as provided above.
- 9) Any such implied warranty of merchantability and/or fitness is limited to the duration of this MINOX Lifetime Total Coverage Warranty. This warranty does not obligate MINOX GmbH or MINOX USA, Inc. to reimburse the original purchaser or any user of the equipment for any expenses, loss or other incidental or consequential damages which may arise in connection with any use of the equipment. Some states do not allow limitations on how long an implied warranty lasts, and some do not allow the exclusion of limitations of incidental or consequential damages, so the above limitations may not apply to you.
- 10) The MINOX Lifetime Total Coverage Warranty gives you specific legal rights, and you may also have other rights which vary from state to state.
- 11) To gain the benefits of the MINOX Lifetime Total Coverage Warranty, your product purchase must be registered within 30 days of date of purchase. In the absence of registration, products requiring service should be returned as directed above with a copy of the original sales receipt. Warranty coverage for such non-registered products shall be a Lifetime Limited Materials and Workmanship Warranty which provides only for product repair or replacement in instances of manufacturing or material defects.
